#### 4. Graduate researcher development

There were no items for discussion.

## 5. Deferral/Suspension of Study Update

The Chair informed members that a deferral of study and a suspension of study is managed differently from the perspective of a student's period of registration: a deferral of study counts towards a student's maximum registration, whereas a suspension of study does not.

The Chair informed members that it is necessary, therefore, to distinguish between the deferral of study and the suspension of studies processes, and to develop separate corresponding guidelines. He explained that a deferral of study would apply to a one-off scenario and will not require supporting documentation, while a suspension of study would apply to a potentially ongoing scenario and will require supporting documentation.

The Chair informed members that these processes and guidelines will be revised on an ongoing basis as requests are submitted, which will allow for better agility as requests are managed on a case-by-case basis and in accordance with the individual circumstances of each student.

It was <u>noted</u> that there is now alignment between *Marks and Standards* and *Academic Regulations for Postgraduate Degrees by Research and Thesis*. The Chair informed members that further considerations are ongoing in the higher education sector regarding the supports provided to PhD students, which may impact on how deferral of study and suspension of study requests are managed.

### 5.1 Deferral of Study Guidelines & Application Form

The Chair informed members that the form now reflects the requirements of postgraduate research students, in particular, the need for a period of deferral rather than a semester. Two separate dates by which students must submit a deferral of study request are indicated on the form. These dates are aligned with the submission deadlines for the Student Record Systems (SRS) returns, required by the Higher Education Authority (HEA) and are intended to reduce the number of retrospective requests that must be considered under Chairs Action.

## 7. Guidance in Respect of Research Student Appeals – Revisions

The Chair informed members that the revisions to 'Guidance in Respect of Research Student Appeals' reflect the changes to Section 13: Appeals in *Academic Regulations for Postgraduate Degrees by Research and Thesis* that were approved by GRSB on 30 March 2023 (Item GRSB2023/A4/6.2).

#### **Noted**

The Chair explained that, while the proposed change to the grounds of appeal was not approved by the Board on 30 March 2023, the change was retained in the version of *Academic Regulations for Postgraduate Degrees by Research and Thesis* that was submitted to University Standards Committee and subsequently to Academic Council for approval.

It was <u>noted</u> that this change relates simply to the presentation of the grounds of appeal rather than altering the grounds themselves. The Chair informed members that the grounds for appeal will be kept under review during the 2023/24 academic year.

## 8. GTE Modules / Doctoral Pathways Update

The Chair informed members that the process for approving Doctoral Pathways must be revised due to the requirement that all documentation is made available in an accessible format, which means that each Doctoral Pathway must be presented as a webpage. The Academic Secretariat and the Graduate Studies Office are currently preparing a single guidance document for the approval of Graduate Training Element (GTE) modules and Structured Doctoral Pathways (SDPs).

The Chair informed members that the guidance document will include a template for SDPs and will set out a more streamlined approval process within Faculties and by GRSB. Relevant individuals in the Faculties will be consulted once a draft of the guidelines and the template are developed to ensure that both are practicable and aligned with the academic governance structures within the Faculties.

The guidance document will be made available during Semester 1 of the 2023/24 academic year so it can be used by Faculties when developing and approving GTE modules and SDPs for the 2024/25 academic year.
